Alessia Tisci

A Sud

Alessia Tisci is an activist and Junior Project Manager for the association A Sud. She holds a Master's Degree in International Relations and Global Security with a thesis in international environmental law focused on climate litigation. For A Sud, she collaborates with the "Giudizio Universale" campaign, which represents the first Italian climate litigation case, and with other projects related to environmental law, climate justice and human rights issues.

Barbara Dombrowski

Climate art in public spaces

For the last 10 years Barbara Dombrowski has dedicated her work to places affected by climate change. She focused on five relevant and specific climate localities on every continent and their indigenous population: Achuar in Ecuador, Inuit in East Greenland, mongolian Nomads in Desert Gobi, Maasai in the Republic of Tansania and Micronesians in Kiribati. Man-made climate change is not only a massive threat to nature, ecosystems and biodiversity, but above all, to people themselves. This is the main theme of the project. After portraying the peoples and landscapes, Barbara brought their pictures in spectacular photo-art-installations in the Amazonia, Greenland and in and around the Hambach Forest, on the apron of the open-cast lignite mine, together. By combining the people, Barbara builds a bridge between them, their regions and cultures and shows that everything is interwoven.

He has devoted much of his professional life to exploring two main themes: migration and social violence. He works at Ruido Photo. One of RUIDO Photo's latest projects is PRIMARY – On the Front Line of Deforestation, a documentary-photography series addressing deforestation and its human and ecological impacts. The collective has actively engaged with the climate crisis in initiatives such as Photojournalism and Climate Crisis Webinar (2023), where two of its photojournalists shared their experience in planning, producing, and distributing a documentary project centered on climate change. Through a combination of photography, participatory workshops, exhibitions and other formats, RUIDO Photo continues to explore environmental degradation, environmental justice, and the intersection between ecological crisis and social issues globally.

Erasmo Palazzotto

Arci, Protection Hub

Erasmo Palazzotto has been working for years on human rights, migration, and civic space. He works for the Italian NGO ARCI. He was a member of parliament and president of the Giulio Regeni Commission of Inquiry. He founded the NGO Mediterranea, which rescues migrants at sea, and is currently head of TOM Tutti gli occhi sul Mediterraneo (All Eyes on the Mediterranean) project and coordinates the program on civic space and criminalization in Italy for ARCI.

He is an associate member of the Transnational Institute and founding member of Greenpeace Italy, he has worked for years as a policy advisor for indigenous peoples' organisations on climate and rights issues, and was the creator of the Zero Tolerance Initiative, a global network for the protection of defenders of the earth and the rights of indigenous peoples. Twice elected Senator of the Republic (2001-2008), he was a member of the Foreign Affairs Committee and secretary of the Human Rights Committee, and is co-founder of the artistic platform A4C-artsforthecommons.

Giulia Torta

Dr. Giulia Torta graduated in Law from the University of Bologna and earned a II-level Master's degree from Sapienza University of Rome, followed by a specialization diploma in Legal Professions from LUMSA University. She obtained her Ph.D. in Human Rights: Evolution, Protection and Limits at the University of Palermo and later completed a postdoctoral fellowship at the Federal University of Paraná (Brazil), where she conducted research on water protection and environmental governance. Dr. Torta is currently a Research Fellow in Administrative Law at the Department of Law of the University of Palermo and a qualified lawyer at the Bar of Palermo. Her research focuses on administrative and environmental law, with particular attention to land use and planning, urban development, and the role of public administration in environmental protection and cultural heritage preservation. She teaches Environmental Law, Land Use and Planning Law, and Protection of Cultural Heritage at the University of Palermo.

Over the years, he has provided consultancy to several national and regional public institutions on environmental governance and sustainability policies. He also serves as Scientific Director and Coordinator of the second-level Master's Programme in Law and Techniques of Ecological Transition, jointly organized by the Departments of Law and Engineering.

Unai Reglero and Gabriela Córdoba Vivas


CaldodeCultivo
